To Our Customers

This is your music instrument lease. Please read it carefully and sign at the bottom of this page. The form will refer to the person signing below who is leasing the instrument as "you" and Kot's Violins as "us".

Lease Term

Both the term of your lease and the due date are shown at the upper right. You must return the instrument or renew your lease by this date.

After this date, your account will be considered overdue and a \$10 late fee will be added to your account. We will try our best to reach you via the contact information that you provide through this form but if you do not respond within three days after it is due, we will automatically renew your lease.

Once your instrument is more than 30 days overdue, or if your credit card is declined, we will turn your account over to a collection agency. If this happens, you will also be responsible for paying all collection expenses, court costs, and attorney fees.

Free Maintenance

Our instruments are made of wood, which expands and contracts with heat or humidity. Because of this, they need to be adjusted several times a year to maximize sound quality and playability. It is highly recommended that you bring your instrument to us every 3 months for free maintenance. Our free maintenance program does not cover string replacements or repairs to correct abuse or misuse.

Loss and Damage

You must return the instrument in typical condition for its period of use. You are responsible for any damage beyond normal wear and tear. If the instrument is lost or damaged beyond repair while under this lease, you agree to pay the full amount of the loss value shown above. It is extremely important that you report damages to us as soon as possible after they happen because damages will often worsen over time and increase the cost to repair.

Protection Plan

If you choose to enroll in our protection plan, we will cover the expenses if the instrument is damaged. We will also cover the expenses if the instrument is stolen as long as you provide us a police report of the incident. We do not cover instrument losses or string replacements.
